Fall Classes Payment and Registration Policy

*PIF=pay in full

The fall schedule of classes will be posted by July 1, 2011 and will be created based on registration numbers, student placement by teachers and teacher schedules.

Classes are 60 minutes unless otherwise noted. Aerial classes are 90 minutes unless otherwise noted.

Options

1. Pay in full at time of registration [5% discount off total class fee]
2. Pay in six installments [payment one and registration fee due at time of registration no later than Sept.; payments two-six due on the first of the month, October - February 2012]
3. Note: we do not have a 9 month payment option. We accept Visa, Master Card, Discover and American Express. Please make checks payable to Studio 180 Dance.

REDEFINING DANCE

Payment, Refund and Registration Policy:

Payment is due upon registration.

Class Space is reserved. There will be a 30 day drop period at the beginning of the year. During this period, a dancer can decide to drop a class and can be refunded their tuition. However, the refund will be pro-rated based upon how many classes the dancer has taken. For example, if the dancer has taken two classes, they will only receive a refund for the last two classes of the month. After that period, however, no refunds or credits can be given for missed or dropped classes or dance programs. Registration fees, deposits, and tuition will not be refunded. Registration fees & tuition are due upon registration.

Tuition Payment Options for 2011-2012

1. Annual tuition may be paid in one payment in September at the time of registration, with a 5% discount.
2. Annual tuition may be paid in 6 equal payments on the first of each month, September 2011 through and including February 2012.
3. For any dancers registering after December 2011, tuition for January through May is due in full upon registration.

We do not send out late notices nor tuition due notices. It is your responsibility to pay tuition on time per your contract. We require each family to provide a valid credit card upon registration. Tuition is due on the 1st of the month. We offer an automatic payment option for those families who would prefer to have their tuition charged upon the first of every month to avoid incurring late fees. If you choose not to use the automatic payment plan, the card will only be used if tuition is delinquent. As of the 9th of each month, should tuition not be paid, Studio 180 will charge the credit card on file for tuition and a \$10 late fee. I give Studio 180 permission to charge my credit card for late payments. The charge will only be made if payment has not been received by the 8th of the month. _____
